With this in mind he stated that the changing accommodation is not suitable and he is now seeking advice as to what can be done to improve matters. • Ayre Lodge [Old Rectory] has been sold and the new tenants arrive next year. However the matter of the boundary between the lodge and the playing field must be re-instated since it is not in the correct place at present. This repositioning must be carried out before the new tenants arrive and David Brown has it in hand. • The small gate onto Back Lane has once again been broken and this time must be replaced as unable to be repaired. • David Brown also stated that he needs to widen the splay at the entrance to the playing field and has asked TGC to help with this job. Two new removable posts have been purchased to put at the entrance but the widening work needs to be done first.

Dear Parish Council, Simon Harley C Cllr.

My report is as follows:

I have been attending induction training sessions over the last month in subjects such as Cyber security, Understanding the Council's decision making process, Committees, Finance, Procedures at Meetings, Equality and Inclusion, Growth, Highways and Infrastructure, Public Health, Adult and Community Services, and have quite a lot more to attend in June and July.

There has not been much in the way of Council business at the stage of the 4 year cycle but we had the AGM of the County Council at Wherstead Park on 27th May. The next full Council Meeting is on 8th July.

The meeting on 27th May was a formal session essentially to decide the new administration structure and individuals. The Conservative Party are a very dominant force with 55 Councillors and nominated and elected Graham Newman again as Chairman and Matthew Hicks as Leader of the Council. They also nominated the Chairs of all the Committees including those of Scrutiny, despite it being pointed out that it was felt to be good practice to include members of the opposition group in at least some of these posts.

The opposition 'GLI' group, of which I am a member, comprises the 9 Green Party Councillors with 4 Liberal Democrats and 2 Independents. The leader of this group is Andrew Stringer. I have been appointed group spokesperson on Public Health and Biodiversity.

The dominant group have promised to 'Build back better and greener' and we will be trying to hold them to account for this, and work for the benefit of all the people of Suffolk.

My other work this month has consisted of responding to emails from residents, usually about Highway matters, and registering these problems with Highways.

District Council Annual Report for Orwell Ward from Cllr Jane Gould

May 2021

The last year has been a very different one for all of us, defined by the Covid pandemic. For many, it has been a difficult year and the insecurity and fear will be with us as we move forward into the year ahead and, hopefully, start to return to a more normal day-to-day life.

COVID

During the last year Babergh Council have been working with partners and other local authorities across the county to ensure that the communities have received the support that they need. Local community groups that sprang up in our towns and parishes were offered support and a support line 'Home but not alone' was set up for anyone that may need it. There was also financial support for residents facing hardship due to self-isolation. As businesses across the county were forced to close, they were contacted by councillors and officers to ensure that they received the grants they were entitled to. Measures were put in place to ensure that council housing tenants were not evicted should they suddenly find that they were unable to pay their rent.

Unfortunately, many services had to be suspended during the lockdowns including our leisure facilities, face to face access points and some waste services. As we now exit the 3rd lockdown these services are slowly returning.

One of the main changes this year has been the move to virtual meetings. We all now know what Zoom is and, "you're still on mute" has been the statement of the year. Following a short suspension of all council meetings and a change in the way planning applications were decided for a while, we settled into a routine of attending all meetings from the comfort of our own home. One change that has come about from this is the ability for councillors to vote electronically. While this means the public cannot see the vote as it happens it is available online within 24 hours.

Recently a significant new grant fund has been launched by Babergh and Mid Suffolk District Councils, it is set to support the recovery of local businesses that are reopening after lockdown but are unable to access the Government's Restart Grant scheme. The councils' Discretionary Restart Grant is designed to help with costs
