5. Clerk's Report

A post of one of the dog bins at the playing field had rotted. This has been replaced by Mr Connell-Smith. He was thanked by the Parish Council.

7. Open Forum for members of the Public

Concern was raised by the member of the public regarding the proposal of the Cricket Club to dig up the 'square' in the week before the village fete. This is the responsibility of the Playing Field committee. Cllr. Self will look into it.

8. Report from District Councillor McCraw

On 1st October, Babergh District Council moves offices from Hadleigh to Endeavour House in Ipswich. There will be no public access, although this is still available at Sudbury and Stowmarket.

The Babergh and Mid Suffolk Joint Local Plan is now out for consultation. He urged Parish Councils and residents to look at it carefully as it will affect planning for the next 20 years. He offered his services to Parish Councils over their response to this document.

Report from County Councillor Wood

He would shortly be in touch with the headteacher at Tattingstone CEVC Primary School about the provision of a 20's Plenty zone y school in Church Road.

The Ipswich Half Marathon will take place on 24th September and this will involve closure of several roads in the Wherstead area. The road closures will not affect emergency vehicles. This is a prestigious event and will bring publicity and tourists to the area.

C.Cllr. Wood is liaising with highways department regarding the state of some of the hedges in the neighbourhood.

The Rose House, The Heath, Tattingstone, IP9 2LX Erection of 9 dwellings

Not Recommended

Grounds:

- I. Ingress and Egress onto the site is dangerous. This is an accident black spot: there have been countless accidents at this point on the A137 including a fatality.
- II. Although a 30 mph limit, cars and lorries are regularly travelling above this speed as a recent traffic survey confirmed.

Extract from letter from Suffolk Police:

For drivers travelling towards Ipswich, 16.7% of vehicles were captured travelling over the NPCC guidelines of 35mph and above.

For drivers travelling towards Brantham, 24.3% of vehicles were captured travelling over the NPCC guidelines.

III. Visibility splays are completely insufficient.

IV. The road bend at this point is far greater than shown on your maps.

V. The density of housing on the site is too high.

VI. There is no proposed affordable housing.

VII. It is out of character with the development at The Heath which is ribbon development. It is purely back filling.

VIII. For residents to access the rest of the village facilities – bus route, church, school, Public house, residents would have to cross the busy A137. There is no crossing.

A notice will be put in Tattingstone News about the meeting on 9th October to urge parishioners to attend to see what is proposed in the village and surrounding area in the next 20 years.

14. To Review progress on Community Led plan

Cllr. Gipps and Cllr. Mendel are anxious for information as to why neighbouring villages are formulating a Neighbourhood Plan or a Community Led Plan. A letter to ask will be sent.

A Community Led plan, although it has very little power to alter planning decisions at District level, is useful document that expresses holistically what is wanted in the way of amenities within the village. It was agreed that the questionnaire be sent out to villagers to begin this consultation.
