Dear Parish Clerk,

I am writing to confirm receipt of Tattingstone Parish Council's Precept Upon the Charging Authority with a precept for 2021/22 of £12,800.

This will be paid to the Parish in two instalments, 50% in April 2021 and 50% in September 2021.

This precept gives the Parish a Council Tax Band D amount of £55.62. This is an increase of 0.95% on 2020/21. These are the amounts that will be shown on the Council Tax Bill.

Further to the email of the 8<sup>th</sup> January 2021, I can confirm that, in addition to the 1<sup>st</sup> Precept instalment, a grant payment of £195 will be paid to the Parish in April 2021.

Please thoroughly check the information contained in this email and advise me of any discrepancies as soon as possible.
